President's/Vice-President Report

LiR concludes its 24th year of existence this year, which means we will be having a 25th Birthday Party next year. Be watching for ways we will celebrate, and please plan to join in!

At the end of this fiscal year, our membership is 380. This is the first downward trend in a few years, and the Executive Council is looking at potential reasons and will consider changes where indicated. We welcome comments from our membership. This is the first year that we have tracked attendance at individual courses, so we cannot yet see trends there. Be assured that we are not "taking attendance," simply counting people to compare the number to the number that signed up.

We had two well-attended Open Houses in the Fall and Spring. In August, Jason Scappaticci acquainted us with a side of Mark Twain that many of us did not know, as he presented *Mark Twain and the Spirits*. Ed Morin did a fascinating presentation on *The Early Days of Motion Pictures* in Spring. We are sad to say that Ed Morin has stepped down from doing these presentations, and will be sorely missed. Ed has done more than 100 presentations for LiR! Bill Brower prepared the course presentation overviews, and did a great job. Ron Tillen was a hard act to follow, and we so appreciate the many years that Ron did this for us. Our Fall Social was enjoyed by many, who were delighted to hear Mary Jo Burke's presentation of her experiences as part of the Burke Family Singers. In April, *Eleanor Roosevelt* came to call, in the person of Sheryl Faye. Our Program Committee, under the direction of Barbara Laliberte, provided us once again with varied and stimulating courses and field trips. We appreciate Barbara doing double duty, serving as chair of this committee as well as Vice President.

The Membership and Promotion Committee, headed by Lee Felpel and Jim Hamel, saw to it that the Quiet Corner knew what was happening at LiR. Dotti Durst kept our membership informed through our quarterly newsletter. They also represented us at the Senior Exposition at Ellis Tech, and at the Senior Fair held by the Putnam Commission on Aging.

We continued to offer a winter session as a free bonus, with movie and video offerings that provided welcome entertainment and learning during January and February. Class attendance in this session as well as the spring session was adversely affected by the frequent snowstorms, and prolonged winter — something over which we have little control.

We are grateful for the support that QVCC provides to us, through Krissy Larrow, the marketing department, security, facilities management, and the food service department, which not only caters our refreshments but provides a good place for lunch for attendees and committee workers. Heather Plourde works closely with Judy Swayze to provide us with attractive and delicious food at our social events. The library staff troubleshoots when we have technical problems with presentations, and does this with an amazing attitude of helpfulness. Problems do not always occur at convenient times!

LiR continues to give scholarships to QVCC students. On May 2nd we awarded two \$1,000 scholarships to degree students, and one \$800 gift to a continuing education student. Our members donated over \$3,500 this year, almost twice as much as in previous years. Thank You!

Our IT Liaison, Richard Anger, continues to keep us up-to-date on the technology front. He updates our websites and documents, trains volunteers to use the equipment, and resolves many technological problems. He informs us that our website had 5,768 "hits" in a year's time, a decided increase as our membership catches up with using our site.

Charging a nominal fee for our Annual Meeting luncheon helped to cut down on costly no-shows, and we thank you for understanding that we needed to do that and will continue to do so.

Roger Pellerin has been treasurer and chair of our Finance Committee for a number of years, and has now decided to step down. We thank him for a job well done, especially realizing that this is a task that many of us would never touch! We have really appreciated you, Roger.

As you can see, several people are stepping DOWN, and some are stepping BACK a little, after serving as volunteers for many years. Of course, this means that we continue to need others to step UP. We are asking that each of you would consider where you might be able to help...as a presenter, a valuable committee member, a member-at-large on the Executive Council, or an officer. The rewards are many: a sense of accomplishment and service, new friends, socialization, honing new skills, and dusting off old ones, and — dare I say — fun!

Annual Meeting - May 12, 2017

CALL TO ORDER: The meeting was called to order at 12:00 PM in the QVCC cafeteria by president Joan Buell.

PRESIDENT'S WELCOME: There are 418 members. The president thanked the committee members for all their work. Also thanked was Krissy Larrow our college liaison. She mentioned that members can audit college courses for no charge if room is available. There was approximately \$150,000 in scholarships awarded to students including those from LiR.

RECOGNITION AWARD: Bill Brower recognized Ed Morin for all his contributions to LiR including committee memberships, especially the growth of the organization during his chairmanship of the Membership and Programs Committee. Ed has given more than 90 presentations including at Open House.

LUNCH: At 12:15 PM we broke for a marvelous luncheon buffet served by Heather Plourde and her staff.

BUSINESS MEETING: Called to order at 1:00 PM.

- Approval of Minutes: The minutes of last year's meeting were approved.
- *Treasurer's Report*: The Treasurer's Report was presented by Roger Pellerin. As of April 4, 2017, the Financial Report was reflecting a profit of \$8,889. Expenses yet to be incurred for the year were estimated at \$5,406. Therefore, a profit of approximately \$3,500 was forecasted. The Proposed Budget Expenses for FY 2017/2018 totaled \$18,600 and were accepted by the membership on hand.
- *Recognition of Committees:* The committee members were introduced and recognized for all their work.
- *Proposed By-Law and Constitutional Changes:* Richard Anger presented the changes. The quorum requirement to be changed from sixty to fifty. The Curriculum Committee's name to be changed to Program Committee. The changes were approved.
- *Nomination Committee Report:* Ed Morin presented this report. The report was approved.
