Appeals are expected to be submitted during the term for which the appeal is being made.

Beginning in summer 2021, all appeals will be reviewed by the Refund Appeals Committee, and the decision will be made in writing to the student with a copy of the decision kept on file at the attending Registrar's Office.

All appeals will be reviewed within 30 days after receipt of all required and supporting documentation. However, response times may vary depending on the volume of appeals at the time of your request. Please do not disregard any college bill due date while awaiting your appeal decision.
